As Rejuveno's Independent Distributor, I agree as follows:

1. I am 18 years of age or above. Upon acceptance of this application by Rejuveno Worldwide Inc. (hereinafter referred to as RWI), I agree to become an Independent Distributor of RWI.
2. As a RWI Distributor, I have the right to buy RWI products at membership prices and the right to sell RWI's products worldwide in accordance with RWI's Policies and Procedures. In return I will receive commissions and bonuses in accordance with RWI's Compensation Plan.
3. I am an Independent Distributor and not an agent or employee of RWI. I am responsible to declare and pay all local taxes as may accrue from my marketing activities (if any) with RWI.
4. I confirm that neither I nor my spouse (if married) have applied for RWI Distributorship before under any personal or company name, and if this is not my (nor my spouse's) first application to become a RWI distributor, my (or my spouse's) previous distributorship has expired for at least six (6) months.
5. I understand and agree that Distributorship can be inherited (if specified in a will) but cannot be sold, assigned or transferred during my lifetime without the prior consent of RWI.
6. I have the right to cancel my RWI Distributorship at any time. Cancellation will be submitted in writing to RWI at its principal place of business and becomes effective on the date of receipt.
7. I understand that in order to maintain a viable marketing system and to comply with changes in applicable laws, RWI reserves the right to revise prices and the compensation plan from time to time if deemed necessary. However, all revisions will be made after careful consultation with major leaders/Distributors and with a minimum of one month's written notice to all Active Distributors.
8. As a RWI Distributor, I will not make any claims or warranties respecting RWI products which are not contained in official RWI promotional materials. I understand that RWI products are nutritional supplements only and no medical claims are allowed.
9. As a RWI Distributor, I will make no income guarantee, nor will I use actual or photocopies of commission cheques as advertising or promotion material.
10. The RWI sales program does not require Distributors to carry an inventory of products. When I place a new order, I must have sold at least 70% of my last order.
11. RWI's logo, related trade names, marketing system and lists of Distributors names are the sole proprietary property of RWI. I will not use these materials to promote the sale of any products or services not supplied by RWI.
12. This agreement is governed by the laws of Canada.
